I will be responsible for the replacement at full retail value of any equipment rented under this form, but not returned to, the shop. 3. I agree to hold harmless and indemnify the ski shop and its owners, agents and employees for any loss or damage, including any that results from claims for personal injury or property damage related to the use of this equipment, except reasonable wear and tear. 4. I agree to return all rental equipment by the agreed date in clean condition to avoid any additional charges. 5. I understand that there are inherent and other risks involved in the sport for which this equipment is to be used, snow skiing, that injuries are a common and ordinary occurrence of the sport, and I freely assume those risks. 6. I understand that the ski-boot-binding system will not release at all times or under all circumstances, nor is it possible to predict every situation in which it will release, and is therefore no guarantee for my safety. 7. I hereby release the ski shop and its owners, agents and employees, as well as the manufacturers and distributors of this equipment from any and all liability for damage and injury to myself or to any person or property resulting from negligence, installation, maintenance, the selection, adjustment and use of this equipment, accepting myself the full responsibility for any and all such damage or injury which may result. 8. I have made no misrepresentations to the ski shop in regard to my height, weight, age or skier type. 9. I verify that the visual indicators on my bindings correspond to the settings as shown on this rental agreement form. 10. All instructions on the use of my rental equipment have been made clear to me, and I understand the function of my equipment. 11. I accept my responsibility to ski safely at all times, to abide by the Skier Responsibility Code, and to obey all posted behavior notices and other ski area rules and policies. Any equipment I use while skiing, I use at my own risk. 12. If I am signing on behalf of a minor, I recognize that I may not release any claims the minor may have. However, I accept full responsibility for all medical expenses incurred as a result of the minor's participation in or travel to and from 49° NORTH. I also agree to HOLD HARMLESS and INDEMNIFY the Chewelah Basin Ski Corp and it's agents, employees, directors, officers, and shareholders, the manufacturers and distributors of the equipment, from any and all liability for personal injury or property damage which results in any way from negligence for claims brought by or on behalf of the minor.

I understand and accept the fact that alpine skiing, snowboarding and all other various forms of snow play are hazardous sports that have many dangers and risks. I realize that injuries are a common and ordinary occurrence of these sports. I agree, as a condition of being allowed to use the ski area facility and premises, that I freely accept and voluntarily assume all risks of personal injury or death or property damage, and release CMR LANDS, LLC, CMR OPS, LLC, CMR F&B, LLC, 49° North Wintersports Foundation, any & all successor entities or successors in interest (including, but not limited to, individuals, partnerships, LLCs, corporations, etc.), and their agents, employees, directors, officers, and shareholders from any and all liability for personal injury or property damage which results in any way from negligence, conditions on or about the premises and facilities, the operations of the ski area including, but not limited to, grooming, snow making, ski lift operations, actions or omissions of employees or agents of the area, or my participation in skiing or other activities at the area, accepting myself, the full responsibility for any and all such damage or injury of any kind which may result.

I, the undersigned, have read and understand 1. RENTAL RELEASE AGREEMENT, 2. RELEASE FROM LIABILITY. I am signing it freely and of my own accord, realizing it is binding upon myself, my heirs and assigns, and in the event that I am signing it on behalf of any minors, that I have full authority to do so, realizing its binding effect on them as well as myself.
